THIS RELEASE AND WAIVER OF LIABILITY (the "Release") executed on this \_\_\_\_\_ day of \_\_\_\_\_, 2017, by \_\_\_\_\_ (the "Volunteer") in favor of Habitat for Humanity of High Point, Archdale, and Trinity, a North Carolina nonprofit corporation, its directors, officers, employees, and agents (collectively "Habitat"); Progressive Business Media (FT Media Holdings, LLC) including its officers, directors and shareholders; and High Point Market Authority.

The Volunteer desires to work as a volunteer for Habitat and engage in the activities related to being a volunteer. The Volunteer understands that the activities may include constructing and rehabilitating residential buildings, working in the Habitat offices, and living in housing provided for volunteers of Habitat.

The Volunteer does hereby freely, voluntarily, and without duress execute this Release under the following terms:

**1. Waiver and Release.** Volunteer does hereby release and forever discharge and hold harmless Habitat, Furniture Today, High Point Market Authority and their successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's work for these entities.

Volunteer understands and acknowledges that this Release discharges Habitat, Furniture Today, and High Point Market Authority from any liability or claim that the Volunteer may have against Habitat, Furniture Today, and High Point Market Authority with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's work, whether caused by the negligence of Habitat or its officers, directors, employees, or agents or otherwise; Furniture Today; or the High Point Market Authority. Volunteer also understands that, except as otherwise agreed to by Habitat, Furniture Today, or the High Point Market Authority in writing, the entities do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance, in the event of injury or illness.

**2. Medical Treatment.** Except as otherwise agreed to by Habitat in writing, Volunteer does hereby release and forever discharge Habitat from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's work for Habitat.

**3. Assumption of the Risk.** The Volunteer understands that the work being done in this project may include activities that may be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites. In connection thereto, Volunteer recognizes and understands that activities may, in some situations, involve inherently dangerous activities.

## RELEASE AND WAIVER OF LIABILITY

Volunteer hereby expressly and specifically assumes the risk of injury or harm in these activities and releases Habitat; Furniture Today; and the High Point Market Authority from all liability for injury, illness, death, or property damage resulting from the activities of the Volunteer's work on this house.

**4. Insurance.** The Volunteer understands that, except as otherwise agreed by Habitat in writing, Habitat, Furniture Today, and the High Point Market Authority do not carry or maintain health, medical, or disability insurance coverage for any volunteer.

**Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.**

**5. Photographic Release.** Volunteer does hereby grant and convey unto Habitat, Furniture Today, and the High Point Market Authority all rights, title, and interest in any and all photographic images and video or audio recordings made by these entities during the Volunteer's work for Habitat, Furniture Today, and the High Point Market Authority including, but not limited to, and royalties, proceeds, or other benefits derived from such photographs or recordings.

**6. Other.** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of North Carolina, and this Release shall be governed by and interpreted in accordance with the laws of the State of North Carolina. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
